#### 5. Safety Officer complaint

Formal complaints made by the MAAA Safety Officer to the MAAA.

**5.1** The MAAQ secretary accused the MAAA Safety Officer of not actioning Area Approval applications.

Outcome sought:

Public and open written apology for the accusations that were made.

Public and open written apology to MAAQ clubs affected

Correspondence to the secretaries of the impacted clubs (Bundaberg, Capricorn and Sun Coast) advising them of the reason for the delay.

Motion: The MAAA Council recommends the MAAQ apologise with respect to the accusations that were made and in line with the above. Moved Mitch Bannink. Motion was not seconded. Lapsed.

MAAQ made no contact with the MAAA Safety Officer in relation to Area Approvals the complaint was based on, and only lodged the complaint email as an agenda item for the Council meeting on 24 November 2022.
