## **Introduction:**

## **Communication:**

I know one of the complaints from Ordinary Members has been a lack of timely communication response. The entire Exec is working hard to overcome this, but it should be noted most have full time commitments elsewhere so sometimes a same day response is just not achievable.

Receiving minutes from meetings was flagged as an issue early – I do not believe any meeting minutes this last year have taken more than two weeks to be received by Council. Likewise, the minutes from this Council meeting will be out early June at the latest.

We have started a secretary's calendar, so that each State secretary can see deadlines looming, meetings scheduled etc. Moving forward this will hopefully help everyone streamline process.

Tim has also started a communication email direct to individuals which has been well received. Following each email there is always a flurry of notes into the secretary inbox commenting on things discussed.

Also on communication, we have begun collating member stories and will publish these on the website as we go along. With Wingspan no longer in publication, member stories will hopefully meet the needs of those looking for something to read over a cup of tea.
