1. Confirmation of October minutes:

2. Appeal of Council Decision:

Background: At the October 31 Council resolved to issue a warning letter to Terry Bond and Aaron Booth. Council agreed that Terry Bond and Aaron Booth would be removed from the MAAA Council. Terry Bond and Aaron Booth lodged an appeal against the decision. Terry Bond and Aaron Booth were invited to attend the Council meeting but did not.

Motion: The original sanctions imposed on Mr Terry Bond and Mr Aaron Booth at the Council meeting on Oct 31 stand and are now enforceable. **Craig Burkhardt / David Mifsud** Motion passed.

The re-write is underway. A draft will be circulated for discussion when finished.

4 Area Approvals update:

An updated list of applications currently with CASA was shared with Council. 19 Applications currently lodged with another 5 hopefully to be lodged prior to Christmas. It is likely a number of clubs will be restricted to flying below 400ft until the relevant Area Approvals are issued.
